## **OFFICIAL RULES**

You will be automatically sent back to the entry page on the Website, where you will need to check a box agreeing to these Rules and then hit the "Enter" button to complete your Entry. If this box is not checked, you will not be able to enter the Sweepstakes.

For purposes of these Rules, all times and days are Pacific Time. official time-keeping Sponsor's computer is the device for the Sweepstakes. Normal internet access and usage charges imposed by your on-line service will apply. It is your sole responsibility to notify the Sponsor of change in your Address. - **6. PROCEDURES:** All Entries must be received during the Entry Period. On or about January 10, 2017, in a random drawing conducted by the Administrator, potential Winners (as defined in Section 7 below) will be selected from among all eligible Entries received. One (1) first prize ("First Prize") Winner will receive an Ethan Allen gift card in the amount of \$10,000.
