

**K.C.UNDERCOVER MISSION: VACATION SWEEPSTAKES
OFFICIAL RULES (“Rules”)**

NO PURCHASE/PAYMENT OR TEXT MESSAGE NECESSARY TO ENTER OR WIN.

A PURCHASE/PAYMENT OR TEXT MESSAGE WILL NOT IMPROVE ONE’S CHANCES OF WINNING.

MANY WILL ENTER. FEW WILL WIN.

1. SPONSOR: ABC Cable Networks Group, dba Disney Channel (“**Sponsor**”), 3800 W. Alameda Avenue, Burbank, CA 91505.

2. ADMINISTRATOR: Ventura Associates International LLC, 60 East 42 Street, New York, NY 10165 (“**Administrator**”), an independent judging organization whose decisions are final and binding with respect to the sweepstakes (“**Sweepstakes**”).

3. ELIGIBILITY: Open only to persons, who are, as of date of entry, between the ages of eight (8) and eighteen (18), inclusive, (“**Child**”) or a parent/legal guardian (“**Parent**”) or grandparent of an eligible Child, legal residents of, and physically located within, the 50 United States or D.C. (collectively, “**Territory**”), and are not employees of Sponsor or Administrator, Best Western International, Inc. (“**Best Western**”), any Best Western® branded hotel, or 3CI; their respective parent, subsidiary or affiliated companies; or the advertising, promotional or fulfillment agencies of any of them (individually and collectively, “**Entities**”); nor members of their households (defined as people who share the same residence at least three (3) months a year, whether related or not) or immediate families (defined as Parents, children, siblings, step-parents, step-children, step-siblings and their spouses). In order to be eligible to enter or win, you must not have been convicted of, or charged with, a felony or crime of moral turpitude or have anything in your background that could potentially cause harm to the Sponsor’s image, as determined by Sponsor in its sole discretion. Sponsor shall be the final determinate on all eligibility questions and/or issues and such determinations shall be final.

4. ENTRY: You may enter this Sweepstakes during the period beginning at 12:00pm (noon), May 9, 2016 and ending at 11:59pm, September 4, 2016 (“**Master Entry Period**”). Sweepstakes will consist of seventeen (17) weekly drawings (“**Weekly Drawings**”), each with its own separate entry period (“**Weekly Entry Period**”) in order to award a weekly prize (“**Weekly Prize**”) and one (1) drawing at the end of the Sweepstakes (comprised of all eligible non-winning Entries from each Weekly Entry Period) (“**Grand and First Prize Drawing**”) which will award both one (1) grand prize (“**Grand Prize**”) and fifty (50) first prizes (“**First Prize**”) as listed in the chart below. For purposes of these Rules, all times and days are Pacific Time.

Entry may be accomplished in one (1) of two (2) ways:

- (a) **SMS TEXT ENTRY:** You may enter this Sweepstakes, by sending on your cell phone (“**Cell**”) the key word “MISSION” as an SMS text message to the SMS short code 347639 (Disney)(“**SMS Entry**”). SMS Entrants will receive a confirmation SMS text message on their Cell. All Cell entrants must have a text messaging two-way capable phone and digital and SMS service in order to enter the Sweepstakes using the text messaging method. Standard carrier messaging and data charges may apply to each text message sent and received. Text messaging may not be available in all areas. **If you are a minor, as defined by state of primary residence, (“Minor”) you must have the permission of your Parent to enter via SMS Entry. By entering via SMS Entry you grant to Sponsor/Administrator your consent to call your Cell should you be selected a potential winner.**
- (b) **ONLINE ENTRY:** As a registered member (“**Member**”) of Disney.com, you may enter by logging onto DisneyChannel.com/Mission (“**Website**”), logging in with your Member Name and Password and following the “How to Enter” instructions (“**Online Entry**”). If you are not a Member, you may become a Member for free by visiting the Website and registering by providing the requested information on the Registration Form through the link on the site: “Not registered?” After registering, you may enter the Sweepstakes by following the above instructions. Parent of a child under the age of 13, who has not previously registered, will be sent an email notifying him/her of the child’s registration and Online Entry into this Sweepstakes. No response by the Parent to the email

is required for the child to enter: however, if the Parent does not want his/her child to enter, Parent may click on a link in the email and complete the steps required to cancel the child's Online Entry and delete the child's information. Normal Internet access and usage charges imposed by your on-line service will apply. It is your sole responsibility to notify the Sponsor of a change in your or your Parent's email address ("**Address**"). To do so, go to <http://register.go.com/go/memberservices/home>, log into your Website account with your Member Name and Password, click on "Modify" and follow the instructions on how to change the Address.

"Entry" shall mean and refer to each SMS Entry and Online Entry.

5. LIMITATIONS: All Entries for each Weekly Drawing must be received during the applicable dates listed in the chart above in order to be considered for that specific Weekly Drawing. For avoidance of doubt, Entries from a Weekly Entry Period will **not** roll over into subsequent Weekly Entry Periods, however, all eligible non-winning Entries **will** roll over into the Grand and First Prize Drawing. All Entries for the Grand and First Prize Drawing must be received by 11:59pm, September 4, 2016. **Entries are limited to one (1) Entry per person/Cell/Address per day (regardless of method of Entry or whether one person has more than one Cell/Address or more than one person use the same Cell/Address). Neither the Entities, nor any of their officers, directors, shareholders, employees, agents or representatives (individually and collectively,

“Releasees”) are responsible for Entries from persons residing, or physically located, outside the Territory; Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Rules; lost, interrupted or unavailable network, server, Internet Service Provider, Website or other connections, telephone or Cell text messaging availability or accessibility; miscommunications; failed computer, satellite, telephone or cable transmissions, lines or technical failure; failed phone, computer hardware or software or text message malfunctions, failures, technical errors or difficulties; telephone transmissions; technical failures; unauthorized human intervention; traffic congestion; garbled or jumbled transmissions; undeliverable emails resulting from any form of active or passive email filtering; insufficient space in entrant’s email account to receive email; or other errors of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; even if caused by the negligence of any of the Releasees. Each of such potential Entries will be disqualified and any attempt by a person to use multiple email or Cell accounts to register more than the number of Entries allowed by these Rules may result in disqualification at Sponsor’s sole discretion. Void where prohibited or restricted by law and subject to all applicable federal, state, local and municipal laws and regulations.

6. PRIZES: ONE (1) GRAND PRIZE: A three (3) day/two (2) night trip for Grand Prize winner (**“Grand Winner”**) and three (3) guests (the **“Guests,”** and together with the Grand Winner, the **“Group”**) to the Los Angeles, CA area (**“City”**), on Sponsor-selected dates to participate in a spy-themed scavenger hunt and meet Zendaya, star of Disney Channel’s K.C. Undercover (**“Show”**), timing subject to talent availability (**“Meet and Greet”**), consisting of the following elements for the Group (**“Trip”**): **[1]** hotel accommodations at a Best Western branded hotel (one standard room/quad occupancy, including room tax) for two (2) nights; **[2]** participation in a spy-themed scavenger hunt; **[3]** a Meet and Greet (timing subject to talent availability) with Zendaya at a location in Los Angeles (chosen by Sponsor); **[4]** hotel/Meet and Greet and scavenger hunt transfers (as applicable and determined solely at Sponsor’s discretion); **[5]** if Grand Winner’s residence is located more than two hundred fifty (250) miles from the City, round-trip coach air transportation on a Sponsor-

selected carrier between a Sponsor-selected major metropolitan airport near Grand Winner's residence ("**Airport of Origin**") and a Sponsor-selected airport in or near the City; but if Grand Winner's residence is located two hundred fifty (250) miles or less from the City, round-trip ground transportation via a Sponsor-selected method between Grand Winner's residence and the hotel; and **[6]** airport/hotel transfers if air transportation is provided. All expenses not specifically mentioned herein are not included and are solely the Grand Winner's responsibility, including but not limited to: roundtrip transportation between the Grand Winner's residence and any Airport of Origin, alcoholic beverages, tax, food, gratuities and tips, insurance, laundry service, merchandise, parking, room service, service charges, souvenirs and telephone calls. Travel and lodging are subject to availability, certain restrictions, blackout dates and Sponsor's approval. Scavenger hunt and Meet and Greet timing are subject to talent availability. Airline carrier and hotel regulations and conditions, including but not limited to any age restrictions and requirements, apply. Grand Winner must complete Trip on Sponsor-selected dates and **no later than September 4, 2017**, or Grand Prize will be forfeited in its entirety and, at Sponsor's discretion, awarded to an alternate winner. Travel arrangements must be made through Sponsor's agent and Sponsor shall determine airline and flight itinerary in its sole discretion. Once the travel schedule has been arranged, it cannot be altered and failure of Grand Winner to follow such schedule shall not obligate Sponsor in any way to provide him/her with alternate arrangements. Releasees are not responsible for airline cancellations or delays. Sponsor will not replace any lost, mutilated, or stolen tickets, travel vouchers or certificates. Approximate retail value ("**ARV**") for Grand Prize: \$6,000 which will vary depending upon points of departure and destination and seasonal fluctuation of hotel rates and airfares. **FIFTY (50) FIRST PRIZES:** one (1) promotional \$100 Best Western Travel Card® redeemable at any Best Western branded hotel (ARV: \$100). **SEVENTEEN (17) WEEKLY PRIZES:** one (1) iPad® mini 2 in Space Gray with 16GB with Wi-Fi only (ARV: \$269). Prizes are not redeemable for cash or transferable, except the Grand Prize is transferable to a surviving spouse residing in the same

household. No substitution allowed except, at Administrator's sole discretion, a prize of equal or greater value may be substituted. Administrator will not replace any lost or stolen prize. 7. PROCEDURES: All Entries must be received during the Master Entry Period, and to be considered for a specific Weekly Prize, Entries must be received during an applicable Weekly Entry Period. On or about the dates listed in the chart in Section 4, in random drawings conducted by the Administrator, the potential winners will be selected from among all eligible Entries received. The decision of the Administrator shall be final and binding. Odds of winning a Weekly Drawing depend on the total number of eligible Entries received during the applicable Weekly Entry Period. Odds of winning the Grand Prize or a First Prize depend on the total number of eligible non-winning Entries received during the Master Entry Period.

8. WINNERS: On or about two (2) business days after each drawing date (listed in the chart in Section 4), potential winner(s) or their Parent will be notified via email or cell phone, as appropriate, to obtain their mailing addresses as well as any additional required information or responses. Once a mailing address is available, the potential Grand Winner or their Parent will be sent paperwork by overnight delivery service. Weekly Prize Winners and First Prize Winners will not receive any further paperwork. All legal responsibilities of a Minor entrant under the Rules will be assumed by a Parent; and a Minor winner's prize will be awarded in the name of the Parent for the benefit of the Minor. At the sole discretion of the Administrator, disqualification, forfeiture and the selection of an alternate winner may result from any of the following: **[1]** a potential winner's failure to respond to notification within **four (4) business days** after transmission; **[2]** the return of an email notification as undeliverable after three (3) attempts; **[3]** the return of any other notice or a prize as undeliverable; **[4]** a potential winner's failure to provide Administrator with satisfactory proof of age, identity, residency and Minor winner's consent of Parent; **[5]** a potential winner's failure to provide Administrator with satisfactory proof that he/she (or Parent) is the authorized account holder of the Cell or Address associated with the

winning Entry; **[6]** a potential winner's failure to provide required additional information upon Administrator's request; **[7]** the potential Grand Winner's failure to execute and return an Affidavit of Eligibility/Liability/Publicity Release within **five (5)** business days after its mailing; **[8]** the potential Grand Winner's failure to be available to complete the Trip on a Sponsor-selected date before September 4, 2017; **[9]** a potential Weekly Prize Winner and/or First Prize Winner's failure to claim any prize within four (4) business days after it is sent; **[10]** a potential winner's failure to validly claim any prize by October 31, 2016; and **[11]** any other non-compliance with Rules. All Weekly and First Prizes for qualified winners will be delivered within 12 weeks after Administrator's receipt of valid mailing addresses and verification of eligibility and compliance with these Rules, including return of all required documentation. including but not limited to payment of re-use fees, residuals or license fees; **[21]** Sponsor shall have the right to make such changes to the Fulfillment Filming and make such uses thereof as it deems necessary or desirable, including but not limited to the right to use, edit, and reproduce and/or alter the Fulfillment Filming in perpetuity, in its entirety or in part, for any commercial and promotional purposes worldwide without any consultation or additional permission, or compensation, credit or attribution; **[22]** Administrator has the right to conduct a background check (“**Check**”) of any and all records of each member of the Group, including without limitation, civil and criminal court records and police reports, which he/she, to the extent necessary under law, shall authorize; **[23]** Administrator may take all steps necessary to corroborate any information provided and each member of the Group will be obligated to provide necessary contacts and information for the Check; **[24]** if the results of such Check yield any felony, crime of moral turpitude charges or conviction(s) or indicates anything that could potentially cause harm to the Sponsor’s image, Sponsor reserves the right in its sole discretion, to disqualify any potential or actual Winner and Sponsor will have no further obligation to said potential or actual Winner; **[25] neither the Trip, Meet and Greet nor participation in the scavenger hunt can be sold, nor can Grand Winner charge members of his/her Group for participating in the Grand Prize;** and **[26]** your Parent is solely responsible for all fees incurred through your wireless phone service for text messages associated with participation in this Sweepstakes.
