ELIGIBILITY:** DISNEY MAGIC SWEEPSTAKES (THE "**PROMOTION**") IS OPEN AND OFFERED ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND DISTRICT OF COLUMBIA, WHO ARE THIRTEEN (13) YEARS OF AGE AND OLDER AND WHO HAVE A TWITTER ACCOUNT IN GOOD STANDING. 4. **ENTRY PERIOD:** The Promotion begins on July 6, 2018 at 7:00:00 AM Pacific Time (“PT”) and ends at 6:59:59 AM PT on July 9, 2018 (the “**Promotion Period**”). The Promotion consists of three (3) separate and distinct daily sweepstakes (the “**Daily Sweepstakes**”). Each Daily Sweepstakes entry period (the “**Daily Sweepstakes Period(s)**” or “**Daily Period**”) is provided in the chart below (the “**Entry Chart**”). The Administrator’s database clock is the official timekeeper for this Promotion.
  
5. **HOW TO ENTER:** To enter this Promotion, each person (or “**Entrant**”) must be a registered member/user of the Twitter application or [www.twitter.com](http://www.twitter.com). Registration is free and can be obtained by downloading the Twitter application to your mobile device or visiting Twitter’s website (listed above) and filling out the required information to obtain an account (an “**Account**”). Once a registered member on Twitter, to enter during the Promotion Period: (a) Entrant must log into his/her Account during the applicable Daily Sweepstakes Period and, (b) participate in the posted task for that day (each a “**Daily Task**”) as outlined in the Entry Chart below to receive one (1) entry into that Daily Sweepstakes (“**Entry**”). **NOTE: To receive an eligible Entry, an Entrant must include the hashtag #DisneyMagicSweepstakes (the “Hashtag”) in the tweet.**

**6. ENTRY CONTENT RESTRICTIONS:**

Entries must not contain material that:

- a) Violates or infringes another's rights, including without limitation, privacy, publicity or intellectual property rights, or that constitutes copyright infringement;
- b) Promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation or age;

- c) Contains indecent or unsafe behavior or situations, profanities or obscenities, including but not limited to use of firearms/weapons/ammunition, nudity, gambling, or pornography, or is otherwise inappropriate, indecent, profane, obscene, violent, hateful, tortuous, slanderous or libelous;
- d) References persons or organizations without their written permission other than that of Sponsor;
- e) Disparages any persons or organizations;
- f) Includes threats to any person, place, business, or group;
- g) Is in violation of or contrary to all applicable federal, state, municipal, or local laws and regulations;
- h) Contains anything that is determined to damage or diminish the goodwill of the Released Parties (defined below in Section 11), as determined by such entities solely in their respective discretion; or
- i) Does not comply with the terms or conditions or guidelines posted by Twitter

Failure of any Entry to comply with the above "**Entry Content Restrictions**," as determined by Sponsor, in its sole discretion, may result in disqualification of Entrant. ## **7. RANDOM DRAWING AND WINNER NOTIFICATION:**

There will be one (1) winner for each Daily Sweepstakes (each a "**Grand Prize Winner**" or "**Winner**" and collectively referred to herein as "**Grand Prize Winners**" or "**Winners**"). Trip 2 Picture and Trip 3 Picture will be collectively referred to herein as **“Picture”**.

Trip 2 Premiere and Trip 3 Premiere will be collectively referred to herein as **“Premiere”**.

**9. PRIZE CONDITIONS:**

If a Grand Prize Winner is a minor in his/her jurisdiction of residence, Guest (or at least one (1) of the Guest(s)) must be his/her parent or legal guardian.
