

# CLAW-OSSAL TOY GIVEAWAY SWEEPSTAKES

## OFFICIAL RULES

***NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.***

***A PURCHASE OR PAYMENT WILL NOT IMPROVE ONE'S CHANCES OF WINNING.***

***VOID WHERE PROHIBITED. MANY WILL ENTER. FEW WILL WIN.***

**1. SPONSOR:** ABC Cable Networks Group, dba Disney Channel ("Sponsor"), 3800 W. Alameda Avenue, Burbank, CA 91505.

**2. ADMINISTRATOR:** Ventura Associates International LLC, 60 East 42nd Street, New York, NY 10165 ("Administrator"), an independent judging organization whose decisions are final and binding with respect to this Sweepstakes ("Sweepstakes").

**3. ELIGIBILITY:** Open only to persons, who are, as of date of Entry, three (3) years of age or older, legal residents of, and physically located within, the 50 United States or D.C. (collectively, "Territory"), and are not employees of Sponsor, Hasbro, Inc., or Administrator; their respective parent, subsidiary or affiliated companies; or the advertising, promotional or fulfillment agencies of any of them (individually and collectively, "Entities"); nor members of their households or immediate families (defined as parents, children, siblings, step-parents, step-children, step-siblings and their spouses). Void where prohibited and subject to all applicable federal, state, local and municipal laws and regulations.

**4. ENTRY:** This Sweepstakes may be entered via the Internet only by a registered member ("Member") of Disney.com. A Member may enter by visiting Disney.com/Claw ("Website"), logging in with your user name or email address ("Address") and password. Once you are logged in, you will automatically sent back to the entry page on the Website, where you will need to check a box agreeing to these Rules and then hit the "Enter" button to complete your entry ("Entry"). If you are not a Member, you may become a Member for free by visiting the Website and clicking on the "Not registered?" link and providing the requested information on the registration form through the "Create Your Disney Account" section on the Website. Upon becoming a Member by registration, you may enter the Sweepstakes by following the above instructions. If an entrant is a child under the age of 13, the Parent/legal guardian ("Parent") of that child will be sent an email notifying Parent of the child's Entry into the Sweepstakes. No response by the Parent to the email is required for child to enter; however, if the Parent does not want Member to enter, Parent may click on a link in the email and complete the steps required to cancel the child's Entry and delete the child's information.

Normal Internet access and usage charges imposed by your on-line service will apply. It is your sole responsibility to notify the Sponsor if you change your Address. To do so, go to <https://disneyprivacycenter.com/communicationchoices/>, log into your Website account with your user name and password, click on "Modify" and follow the instructions on how to change the Address.

For the purposes of these Official Rules ("Rules"), all times and days are Pacific Time ("PT"). Sponsor's computer is the official time-keeping device for the Sweepstakes.

In the event of any discrepancy or inconsistency between the terms of these Rules and the Privacy Policy (as defined in Section 10 below), the terms of these Rules shall govern.

**5. ENTRY PERIOD:** Sweepstakes commences at 12:00 A.M. PT, November 4, 2015, and ends at 11:59 P.M. PT, December 3, 2015, and will include the following entry periods (each an "Entry

Period”): (i) three (3) separate First Prize entry periods (“First Prize Entry Period”) for a First Prize (each a “First Prize Sweepstakes”); and (ii) one (1) Grand Prize entry period (“Grand Prize Entry Period”) for a Grand Prize (“Grand Prize Sweepstakes”). Neither the Entities, nor any of their officers, directors, shareholders, employees, agents or representatives (individually and collectively, “Releasees”) are responsible for Entries from persons residing, or physically located, outside the Territory; Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Rules; or for lost, interrupted or unavailable network, server, internet service provider, Website or other connections; telephone availability or accessibility; miscommunications; failed computer, satellite, telephone or cable transmissions, lines or technical failure; failed phone, computer hardware or software, failures, technical errors or difficulties; telephone transmissions; technical failures; unauthorized human intervention; traffic congestion; garbled or jumbled transmissions; undeliverable emails resulting from any form of active or passive email filtering; insufficient space in Entrant’s email account to receive email; or other errors of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; even if caused by the negligence of any of the Releasees. Each of such potential Entries will be disqualified and any attempt by a person to use multiple email accounts to register more Entries than allowed by these Rules may result in disqualification at Administrator’s sole discretion. Void where prohibited and subject to all applicable federal, state, local and municipal laws and regulations.

Grand Prize Winner will receive an IRS Form 1099-MISC reflecting the final actual value of his/her Prize.
