## RADIO DISNEY SOUNDS OF SUMMER CAMP SWEEPSTAKES OFFICIAL RULES ("Rules")

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

ENTRANTS UNDER THE AGE OF MAJORITY MUST HAVE PERMISSION FROM THEIR PARENT OR LEGAL GUARDIAN ("PARENT") IN ORDER TO ENTER.

- **1. SPONSOR:** ABC Radio Networks Assets, LLC d/b/a Radio Disney ("**Sponsor**"), 500 South Buena Vista Street, Burbank, CA 91521.
- **2. If this box is not checked, you will not be able to enter the Sweepstakes; OR

Non-Member: If you are not a Member of Disney.com, you may become a Member for free by visiting the Website or App, clicking on the "Not registered?" link and providing the requested information on the registration form through the "Create Your Disney Account" section on the Website or App. In order to become a Member, you will be required to click where indicated to signify that you accept and agree to be bound by the Terms of Use ("TOU") located at <a href="http://disneytermsofuse.com">http://disneytermsofuse.com</a>. Once you are a Member, you may enter the Sweepstakes by following the instructions on the Website or App. You will be automatically sent back to the entry page on the Website or App, where you will need to check a box agreeing to these Rules and then hit the "Enter" button to complete your Entry. If this box is not checked, you will not be able to enter the Sweepstakes.

Parents of a child under the age of 13, whose child has not previously registered to become a Member of Disney.com, will be sent an email notifying him/her of his/her child's registration.

No response by Parent to the email is required for his/her child to register on the Website or the App, however, if Parent does not want his/her child to register, Parent may follow the instructions in the email and complete the steps required to cancel his/her child's registration and delete the child's information.

The App for iPhone, iPad and iPod Touch (iOS 7.0 or later) as well as Android mobile devices is available on Google Play and the iTunes App store. The App is free to download and use, but subject to the listed terms and conditions described within the App. Message and data charges may apply. Standard rates will apply according to the terms and conditions of the Entrant's service agreement with his/her wireless carrier. Other charges may apply (such as normal airtime and carrier charges) and may appear on the Entrant's mobile phone bill or be deducted from his/her prepaid account balance. (2)SMS Text Entry: You may enter this Sweepstakes, by sending on your mobile phone ("Mobile") the key word "Camp" as an SMS text message to the SMS short code 347639 (Disney)("SMS Entry"). SMS Entrants will receive a confirmation SMS text message per each daily Entry on their Mobile. All Mobile Entrants must have a phone capable of two-way text messaging and digital and SMS service in order to enter the Sweepstakes using the text messaging method. Sponsor is not responsible for inability of caller to complete call within specified time, whether due to busy lines, disconnections, telephone malfunctions or other circumstances. From time to time. "Entry" and "Entries" shall mean and refer to each Online, SMS Entry and On-air Super Entry.

**5. LIMITATIONS:** All Entries must be received by 3:00pm, August 24, 2017. Regardless of method of Entry and/or whether a person has more than one Address/Mobile or more than one (1) person uses the same Address/Mobile, only one (1) Online Entry or SMS Entry per Entrant per day is permitted (a maximum of twenty (20) Online Entries or SMS Entries total per entrant during the Entry Period): or only one (1) On-air Super Entry (equal to 100 Entries) per entrant per day is permitted (a maximum of twenty (20) On-air Super Entries total per entrant during the Entry Period).
