

**FEED THE LOVE SWEEPSTAKES
OFFICIAL RULES (“RULES”)**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE OR PAYMENT IMPROVE ONE’S CHANCES OF WINNING.

MINORS MUST HAVE PERMISSION FROM THEIR PARENT OR LEGAL GUARDIAN (“PARENT”) IN ORDER TO ENTER. PRIZE WILL BE AWARDED IN THE NAME OF A MINOR’S PARENT. MANY WILL ENTER, ONE WILL WIN. VOID WHERE PROHIBITED.

This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Instagram®. Each Entrant participating in this Sweepstakes is providing information to Sponsor and not to Instagram. Instagram is a registered trademark. Any questions, comments, or complaints regarding the Sweepstakes must be directed to the Sponsor, and not to Instagram.

I. NAME OF SPONSOR

Radio Disney, a Division of ABC Radio Networks Assets, LLC (“**Sponsor**”), 500 S. Buena Vista St., Burbank, CA 91521, whose decisions are final and binding as to all aspects of this sweepstakes (“**Sweepstakes**”).

II. ELIGIBILITY

To be eligible for this Sweepstakes at the time of entering you (referred to herein as “you” or “**Entrant**”) must: [a] be thirteen (13) years of age or older, [b] be a legal resident of, and physically residing within the fifty (50) United States or the District of Columbia, [c] not be an individual (including, but not limited to, employees, consultants, independent contractors, and interns) who has, within the past six (6) months, performed services for Sponsor, and/or any organization responsible for supplying the Prize (as defined below) or sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes , or their respective parent, subsidiary, affiliated and successor companies (collectively, “**Entities**”), [d] not be an immediate family member and/or household member of an employee of such Entities, and [e] not be any person who, within the past six (6) months, has been awarded a prize in any sweepstakes conducted by Sponsor. “Immediate family members” shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. “Household members” shall mean people who share the same residence at least three (3) months a year.

III. HOW AND WHEN TO ENTER

Entry: You may enter this Sweepstakes via the Radio Disney website (as further described herein) or via Instragram during the period beginning at 11:59 am Pacific Time (“**PT**”), November 20, 2020 and ending at 11:59 pm. PT, December 6, 2020 (“**Entry Period**”). There are two (2) methods of Entry (as defined below) as follows:

1. **Online Entry:** You may enter the Sweepstakes online by doing the following: [1] go to <http://radio.disney.com/> (“**Website**”) find the Sweepstakes section and click “Enter,” and [2] on

the Sweepstakes page click “Enter Now” and provide all requested information, including your email address (“**Address**”) if requested, and click “Submit Entry” if/when asked. Each entry received in accordance with the foregoing and that complies with all requirements of these Rules will constitute and will be referred to herein as an “**Online Entry**.”

2. **Instagram Entry:** To enter the Sweepstakes using Instagram, you must create or have an Instagram account (“Account”) in good standing. Membership on Instagram is free. After you have established your Instagram account, you may enter by doing all of the following: **[a]** signing into your Account via the mobile application, **[b]** be or become a follower of the @radiodisneycountry Instagram account from which Sponsor will post about the Sweepstakes multiple times (“**Sponsor’s Posts**”) starting at 11:59 am PT, November 20, 2020 and ending before 11:59 pm PT, December 6, 2020, **[c]** commenting on one (1) of Sponsor’s Posts and including the hashtag #RDCSweepstakes, and **[d]** tagging one (1) friend after getting permission from him or her to be tagged in the comment. Each entry received in accordance with the foregoing and that complies with all requirements of these Rules, and with all terms, conditions and policies of the Instagram® photo filtering and sharing service, will constitute and be referred to herein as an “**Instagram Entry**.” Instagram Entries will not be judged.

“**Entry**” and “**Entries**” shall mean and refer to each Online Entry and Instagram Entry. Entries remain the property of the Sponsor and will not be returned. All Entries must be received or credited by 11:59 pm, December 6, 2020.

Regardless of method of Entry and whether a person has more than one (1) Address or more than one (1) person uses the same Address, only one (1) Online Entry per Entrant per Day is permitted (a maximum of seventeen (17) Online Entries, per entrant during the Entry Period); and only one (1) Instagram Entry per Account is permitted. Normal internet access and usage charges imposed by your on-line service will apply. Sponsor’s computer is the official time-keeping device for the Sweepstakes.

Mass Entries or Entries generated by a script, macro or use of automated methods will be disqualified. Sponsor is not responsible for late, lost or inaccurate Entries, or failed, partial or garbled computer transmissions or text messages, or for technical failures of any kind, including but not limited to electronic malfunction or damage of any network, hardware or software. No responsibility is assumed for: any error (human or otherwise), omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, providers, computer equipment, or software; or failure of any e-mail or electronic Entry to be received on account of technical problems or traffic congestion on the internet or at any website, or any combination thereof, including any injury or damage to Entrant’s or any other person’s computer related to or resulting from participation in or downloading any materials from this Sweepstakes. In the event of a dispute over an Online Entry, prize will be awarded to the owner of the Address, not the name on the Entry form.

IV. PRIZE AND APPROXIMATE RETAIL VALUES

Four (4) winners (“Winners”) will each receive a prize consisting of the following elements (“**Prize**”): **[a]**

a One Thousand Dollar (\$1000) Visa Gift Card; and **[b]** an opportunity for Radio Disney to donate Five Thousand Dollars (\$5,000) to Feeding America on behalf of all the Sweepstakes Winners, collectively. There are no other Prizes. Approximate retail value ("ARV"): \$4,150. If the actual value of the Prize is less than the stated ARV, the difference will not be awarded. Prize is not redeemable for cash or transferable. Prize shall not be sold or transferred for commercial use. Radio Disney will donate \$5,000 to Feeding America regardless of the Sweepstakes results. All elements of the Prize are determined at the sole discretion of the Sponsor, Sponsor reserves the right, at its sole discretion, to substitute the Prize (or elements thereof) with one of comparable or greater value. Prize elements may not be separated. Prize is awarded "as is" with no warranty or guarantee, expressed or implied, being provided by Sponsor. Any damaged, lost or stolen gift cards, will not be replaced. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes promotional materials and the terms and conditions of these Rules, these Rules shall prevail and govern.

V. HOW AND WHEN SWEEPSTAKES WINNERS WILL BE SELECTED AND NOTIFIED

On or about December 7, 2020, four (4) potential Winners will be selected at random from all eligible Entries received. All legal responsibilities of a minor (as defined by state of primary residence) Winner under the Rules must be assumed by a parent; and the Prize will be awarded to the parent for the benefit of such minor Winner. All Winners must meet all eligibility requirements and must complete and return an affidavit of eligibility/compliance with the Rules, publicity/liability release and indemnification ("**Release**").

1. If a selected Entry is an Online Entry, on or about December 7, 2020 the potential Winner will be notified by an email sent to the Entrant's Address; and will receive Release via email within one (1) day after successful notification. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate Winner may result from any of the following: **[a]** a potential Winner's failure to respond to the email notification within twenty four (24) hours after its transmission (it is an Entrants responsibility to maintain the Address used for Entry for the duration of the Sweepstakes) **[b]** a potential Winner's failure to provide Sponsor with satisfactory proof of age, identity and residency; **[c]** a potential Winner's failure to execute and return the Release within two (2) days after it is received; **[d]** a potential Winner's failure to validly claim the prize by December 11, 2020, and **[e]** any other non-compliance with these Rules.
2. If a selected Entry is an Instagram Entry, on or about December 7, 2020 the potential Winner will be notified via an Instagram Direct Message to the potential Winner's Account ("**DM**") to obtain an email address as well as any additional required information or responses. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate Winner may result from any of the following: **[a]** a potential Winner's failure to become a follower of @radiodisneycountry Instagram account; **[b]** a potential Winner's failure to include the hashtag: #RDCSweepstakes; **[c]** failure of DM due to deactivation of a potential Winner's Account prior to DM; **[d]** a potential Winner's failure to respond to DM within one (1) business day after its transmission; **[e]** the return of a DM as undeliverable; **[f]** a potential Winner's failure to provide Sponsor with satisfactory proof of age, identity and residency; **[g]** a potential Winner's failure to execute and return the Release within two (2) days after it is received from Sponsor; **[h]** a

potential Winner's failure to validly claim Prize by December 11, 2020, and [i] any other non-compliance with Rules.

In the event of prize forfeiture, the Sponsor may, in its sole discretion, award or not award the forfeited prize to an alternate Winner, time permitting. The Prizes will be awarded, provided they are validly claimed by December 11, 2020 after which Sponsor will make reasonable efforts to select an alternate Winner, time permitting.

Odds of winning depend on the total number of eligible Entries received. Many will enter; only one (1) will win. Federal, state, and local taxes are the sole responsibility of the Winner (or their Parent if a Winner is a minor as defined by the state of primary residence), who must provide a validly completed IRS Form W-9 and the total value of the prize will be reported on an IRS Form 1099. If a Winner (or their Parent if Winner is a minor as defined by the state-of primary residence) is not a resident of California he/she will be subject to California nonresident tax withholding at a rate of 7%. Sponsor is not responsible for any circumstances that make it impractical or impossible to fulfill all elements of the prize; Sponsor's only obligation will be to provide the remaining elements, if any, of the prize.

VI. RELEASES

By entering this Sweepstakes and/or accepting any prize, you understand and agree that: [a] you will be bound by these Rules and the decisions of the Sponsor, which shall be final in all respects; [b] you release and hold harmless the Sponsor, its parent, subsidiary, affiliated and successor companies, advertising and promotion agencies and prize suppliers, and each of their respective officers, directors, agents, representatives and employees (collectively, the "**Released Parties**") from any and all liability for claims, injuries, losses or damages of any kind, including without limitation, death and bodily injury, resulting, in whole or in part, directly or indirectly, from the awarding, delivery, acceptance, use, misuse, possession, loss or misdirection of the prize; participation in the Sweepstakes or any Sweepstakes-related activity or travel or from any interaction with, or downloading of, computer Sweepstakes information; [c] the Released Parties do not make any representation, warranty or guarantee, express or implied, relating to the Sweepstakes or the prize; [d] Winner's acceptance of a prize constitutes the grant to Sponsor and assigns of an unconditional right to use your name, voice, likeness, photograph, biographical and prize information, city and state of residence and Entry materials ("**Likeness**") for programming, publicity, advertising or promotional purposes, in any and all media now known or hereafter created or conceived, worldwide in perpetuity, without further compensation unless prohibited by law (Sponsor is not obligated to use any of the above mentioned information or materials, but may do so and may edit such information or materials, at Sponsor's sole discretion); [e] Winner's acceptance of prize constitutes the grant to Sponsor and assigns to discuss Likeness in programs, and Winner acknowledges that such discussion may include statements or opinions by the program talent or others about the Likeness and that those statements and opinions may be considered surprising, humiliating, embarrassing, derogatory, defamatory or otherwise offensive or injurious to them and agrees to release and hold harmless the Released Parties from any actions, claims, injury, loss or damage allegedly caused, directly or indirectly, by any such statements or opinions that may be made regarding the Likeness; [f] if for any reason the Sweepstakes is not capable of running as planned, including but not limited to, infection by computer virus, bugs tampering, unauthorized human or other intervention,

fraud, technical failures, Acts of God, acts or regulations of any governmental or supra-national authority, war, national emergency, epidemic, pandemic, accident, fire, riot, strikes, lock-outs, industrial disputes, acts of terrorism, or other matters beyond the Sponsor's reasonable control, that corrupt, affect, prevent or impair the administration, security, fairness, integrity or proper conduct of the Sweepstakes so that it cannot be conducted as originally planned, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the Entry process, to modify the Rules or to cancel, modify, terminate or suspend the Sweepstakes; and in such event, to determine the Winner using all non-suspect eligible Entries received up to time of cancellation or by such method as Sponsor in its sole discretion shall consider equitable; **[g]** the Released Parties are not responsible for typographical or other errors in the offer or administration of this Sweepstakes, including but not limited to: human error, errors in the advertising, Rules, selection and announcement of the Winner and distribution of the prizes; **[h]** any portion of the prize not accepted or used by the Winner will be forfeited; **[i]** the Released Parties are not responsible for any inability of the Winner to accept or use the prize (or any portion thereof) for any reason; **[j]** the Sponsor has the right, at any time and at its sole discretion, to disqualify any individual it suspects to be doing any of the following: (1) tampering or attempting to tamper with the Entry process or the operation of the Sweepstakes; (2) violating the Rules; (3) violating the terms of service, privacy policy or other terms, conditions of use and/or general rules or guidelines of any Sweepstakes property or service; (4) acting in bad faith, unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person or (5) for any other good cause as determined solely by the Sponsor; **[k]** Sponsor has the right to modify prize award procedures at its sole discretion; **[l]** all disputes, claims and causes of action at law or in equity (individually, "Claim") arising out of or relating to this Sweepstakes, the prize, or the meaning or interpretation of the Rules shall be resolved by applying the laws of California, without regard to conflict of laws provisions therein, and shall be solely and exclusively brought in the state or federal courts within that state; **[m]** all Claims shall be resolved individually, without resort to any form of class action; and **[n]** all Claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event include attorneys' fees, and under no circumstances will you be permitted to obtain awards for, and hereby waive all rights to claim, punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses and waive all rights to have damages multiplied or otherwise increased. Notwithstanding the foregoing, Released Parties shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Rules) in the state and federal courts of Los Angeles County.

VIII. MISCELLANEOUS; SWEEPSTAKES WINNER'S LIST

Void where prohibited or restricted by law and subject to all applicable federal, state, local and municipal laws and regulations.

Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the Entry process and to cancel, terminate, modify and/or suspend the Sweepstakes in the event of tampering or

other circumstances, including but not limited to acts of God or civil disturbance that render it impractical or impossible to complete or fulfill the Sweepstakes as originally planned.
