

Non-Exclusive License

This Non-Exclusive License (“License”) sets out how The Walt Disney Company (“Disney”) would like to use your content.

By replying to our social post you understand and agree to the following terms:

- 1) You represent and warrant that you are at least 18 years old and own all of the “User Content” (avatar, text, profile, images and videos in your post) and there are no third parties who have, or who you reasonably ought to know have ownership claims over it.
- 2) If the User Content is subject to third party proprietary rights, you have all necessary licenses, rights, consents, and permissions (including permissions from all person(s) appearing in the User Content to (i) publish the User Content you submit, and (ii) to grant such rights to Disney. You understand you shall be liable for any claims/costs against Disney resulting from Disney’s use of the User Content.
- 3) You grant Disney a non-exclusive and irrevocable license to reproduce the User Content in any form (including, without limitation: video, internet posting, reproduction, display, email, publication, and distribution), either through Disney’s services, family of companies or services provided by third parties, throughout the world in any medium now known or later developed, and without restriction or limitation. In the event of any dispute with Disney you agree to enter into arbitration and any damages agreed shall expressly exclude injunctive relief.
- 4) You understand that Disney may edit the User Content for production purposes. You agree that the User Content may be used by Disney to create new content based on/incorporating the User Content, either alone or in conjunction with other content. We will not use the User Content in a way which is inconsistent with Disney’s brand values. While Disney will make reasonable efforts to credit your content, for example by providing a link back to your social account, you agree that such credit is not mandatory, and your permission for us to use the User Content is not contingent upon such credit being given. You agree to waive or (where such a waiver is not permissible under the applicable law), you agree not to exercise any moral rights you may have over the User Content.
- 5) You waive any right to inspect and/or approve (i) the finished work incorporating the User Content and any related advertising copy and, (ii) how the finished work is used. Further, you waive any claims to royalties with regards to the User Content or our finished work.
- 6) Your personal information will be used in accordance with our [Privacy Policy](#) and the current data protection and privacy laws and regulations. You expressly confirm and consent to: (i) Disney contacting you in connection with the User Content, (ii) Disney using your personal information to promote the activity as explained to you (iii) your personal information being held and processed by Disney for the purposes of administering Disney’s social media pages, (iv) Disney disclosing such information to appropriate persons and Disney’s professional advisors and (v) the transfer and storage of such information outside the European Economic Area (including to Disney and any Disney affiliates and their business contacted) as may be reasonably required for the purposes set out above.
